The court decrees:

Divorce

1. Rebecca Starr is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Rebecca Starr. The divorce will become final upon entry of the divorce decree.

10. The parties will sign all documents necessary to comply with the divorce decree

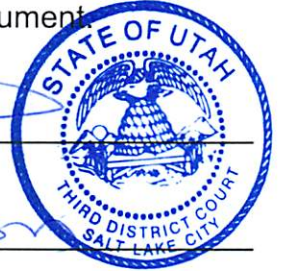
