THIS MATTER came before the above-entitled Court on Petitioner’s *Motion to Enforce Order and for Sanctions and for Additional Relief*, on the 29<sup>th</sup> day of December 2025, pursuant to notice, the Honorable Renee Blocher presiding. Petitioner appeared in person and was represented by her counsel, Joseph Lee Nemelka. Respondent appeared in person but was not represented by counsel. The parties having entered into a stipulation and accepted further direction from the Court, the Court having reviewed the file herein, and good cause appearing,

**IT IS HEREBY ORDERED AS FOLLOWS:**

1. Petitioner, Emi Janae Holland, shall be granted complete and sole authority to obtain the passports for the minor children. Respondent, Chad Russell Holland is ordered to cooperate as necessary. Each party shall pay one-half ( $\frac{1}{2}$ ) the costs of obtaining the passports for the minor children. Petitioner shall maintain possession of the passports but shall not unreasonably withhold them from Respondent if they are needed by Respondent for travel purposes.

2. Petitioner is awarded judgment against Respondent in the sum of \$2,393.50, *including \$2,231.50 for past due amounts as outlined in the motion, and \$162 for December medical premiums.* ~~\$4,207.54 for the \$675 past due marital debts per month for the months of September through December, 2025, plus an additional \$1,507.54 for past due preschool, child Care, school, medical and dental expenses from August through December, 2025.~~

3. Respondent shall pay his court-ordered debt obligations on or before the 1<sup>st</sup> day of each and every month commencing with January 1, 2026.

4. Petitioner is awarded attorney's fees in the sum of \$300 *for one hour of attorney fees. The Court reserves the remainder of attorney fees.* The Court reserves other requests by Petitioner for attorney's fees.

5. Respondent's contempt is reserved pending his compliance with this and other orders in this case. *Respondent may purge his contempt by continuing to make monthly payments on the debt obligations.* Petitioner may seek a review hearing and pursue contempt

and other sanctions

If Respondent fails to comply.
