That the Court after trial on this matter has entered an order for PGAL fees to be paid by Petitioner. PGAL has filed her Affidavit of Attorney Fees. The court having reviewed the fees affidavit, no objections having been filed, the court finds the fees were reasonably and necessarily incurred by the PGAL in her representation of the best interests of the minor children in this highly litigious action between April 2024 and February 2026. The rates charges were

commensurate with the rates charges in this jurisdiction and the time spent was reasonable and the tasks were necessary for the PGAL to fulfill her responsibilities.
