The court decrees:

**Divorce**

1. Juanita Maria Watkins is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Juanita Maria Watkins. The divorce will become final upon entry of the divorce decree.

**Children (Utah Code 81-6-101(7))**

**2. Juanita Maria Watkins and Patrick Wayne Watkins do not have any children together.**

- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- We are not expecting a child.
- We do not have incapacitated adult children together who are eligible for child support, or, **Juanita Maria Watkins** is not asking for child support for any adult child who is eligible for child support.

**8. If the Plan Participant receives any retirement money awarded to the Alternate Payee, the Plan Participant receives that money in a constructive trust for the Alternate Payee. 10. Juanita Maria Watkins changed her name when the parties married. Juanita Maria Watkins's name will be Juanita Maria Rosales after the divorce. Judge's signature may instead appear at the top of the first page of this document.
