In this action, the defendant Jeffrey Lynn Lott, dba Lott's Diesel ("defendant"), having been regularly served with process, and having failed to appear and answer plaintiff Courtland R Love, LLC dba Love Machine ("Love Machine")'s complaint filed herein, the legal time for answering having expired, and the default of defendant in the premises having been

duly entered according to law, now upon the application of Love Machine to the above-entitled court, judgment is hereby entered against defendant in pursuance of the prayer of said complaint.

Wherefore, it is ordered, adjudged, and decreed that plaintiff Love Machine recover from defendant the sum of \$8,456.19, together with interest accruing at 18% per annum from the applicable due date until paid in full, together with \$375.00 in filing fees, together with \$135.00 in service costs, for a total judgment of \$8,966.19.

It is further ordered that this judgment may be augmented in the amount of interest on the principal amount at the rate of 18% per annum continuing from the date of this judgment until paid in full, and also augmented with reasonable costs and attorney fees incurred in collecting said judgment by execution or otherwise as shall be established by affidavit. Pursuant to Utah R. Civ. P. 54(b) and 62, this judgment constitutes a final judgment, having resolved all claims against all parties.
