The Court previously entered an Order granting Plaintiff's Motion for Default Judgment on May 12, 2026. Accordingly, pursuant to Rule 58A of the Utah Rules of Civil Procedure, the Court hereby enters final declaratory judgment in favor of Plaintiff Prime Insurance Company ("Plaintiff") and against Car Go Xpress ("Defendant") as follows:

1. Jurisdiction and venue are proper in this Court and county.
2. Based on the evidence submitted, the facts of the case, and the arguments made in the pleadings, the Court has determined that a hearing is not necessary.
3. Under the undisputed facts of this case, it is hereby ordered:

(a) There is no coverage for the Cucci claim because the involved driver was not a Scheduled Driver.

(b) There is no coverage if the involved vehicle was not a Scheduled Truck.

(c) There is no coverage because the Cucci claim falls under Exclusion No. 2 of the Cargo Policy.

(d) There is no coverage because the Cucci claim falls under Exclusion No. 15 of the Cargo Policy.

(e) There is no coverage if the Cucci claim falls under Exclusion No. 36 of the Cargo Policy.

(f) Pursuant to Exclusion No. 60 of the Cargo Policy, there is no coverage for any Claims or Damages related to the Personal Items.

(g) As coverage is precluded, Plaintiff has no obligation under the terms of the Policy to defend or indemnify Defendant for claims arising out of the April 26, 2025, incident, including the Cucci claim.

(h) As coverage is precluded, Defendant has no right of recovery against Plaintiff under the terms of the Policy for the claims arising out of the April 26, 2025, incident, including the Cucci claim.

It is the intent of this Court that this Judgment disposes of all issues and all parties and that it is a final, appealable order.
