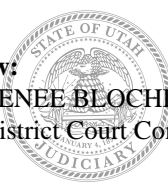

On November 20, 2026, this matter came before the Court, the Honorable Michelle Tack presiding, for a hearing on the Respondent's *Verified Motion to Enforce and for Sanctions* (Dkt. No. 710). Petitioner, Shilo Zitting, was present and represented himself. Respondent, Elizabeth Harper was present and represented by her attorney Brody N. Miles.

The Court, having reviewed the moving papers, heard argument, and being fully advised in the premises, the Court now makes and enters the following:

JUDGMENT AND ORDER

1. Respondent's motion for sanctions is CERTIFIED to the Judge for a determination of attorneys fees and appropriate sanctions.
2. The Petitioner's income is sufficient to pay the child support and expenses ordered.
3. Petitioner, Shilo Zitting, is ordered to pay the amount of \$31,551.42 as follows:
 - a. Petitioner failed to pay child support and is in arrears in the amount of \$29,298.98 as of October 31, 2025.
 - b. Petitioner failed to pay his share of expenses and extra-curricular activities and is in arrears on expenses in the amount of \$2,252.44 as of October 31, 2025.
4. Respondent is awarded a judgment in the amount of \$31,551.42 as of October 31, 2025.
5. The Petitioner's pre-hearing Venmo payments were properly deducted from the amount owed.
6. The Petitioner's payments for birthday expenses and school supplies are deducted from the amount owed.
