## Divorce

**Duty to sign documents**

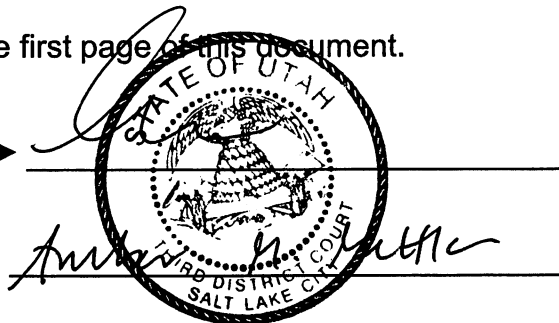
