1. The above captioned Court held a fourth hearing on this matter on May 8, 2026, the honorable Commissioner Blocher presiding. Casey was present via Webex and represented by his counsel, Matthew Bell, and Ms. Chanthoeun Barrus ("Chanthoeun") was also present via Webex and represented herself.

2. At the hearing, the Court found that Casey prevailed on his *Countermotion to Enforce* and ordered a judgment to enter against Chanthoeun for 50% of Casey's attorney's fees related to the *Countermotion to Enforce* with the issue of whether or not a judgment should enter for

the other 50% of those fees being reserved.

3. Casey's counsel submitted a *Declaration of Attorney Fees and Costs* ("*Declaration*") with an itemization of time spent related to that motion and testimony showing that the specific fees were reasonable.

4. This *Declaration* was timely filed with the Court on May 22, 2026.

5. The Court has reviewed the *Declaration* and finds that the attorney fees and costs are reasonable.

6. An executable judgment is hereby entered against Chanthoeun Barrus in the amount of **\$1,417.50** to compensate Casey for 50% the reasonable attorney fees and costs he incurred related to the above referenced motion.
