The Court previously entered an Order granting Plaintiff's Motion for Default Judgment on March 20, 2026. Accordingly, pursuant to Rule 58A of the Utah Rules of Civil Procedure, the Court hereby enters final declaratory judgment in favor of Plaintiff Prime Insurance Company ("Plaintiff") and against Defendant Mendieta and Sons Enterprise, Inc. (collectively "Defendant") as follows:

1. Jurisdiction and venue are proper in this Court and county.
2. Based on the evidence submitted, the facts of the case, and the arguments made in the pleadings the Court has determined that a hearing is not necessary.

3. Under the undisputed facts of this case, it is hereby ordered, adjudged and decreed:

a. There is no coverage under the Policy as the March 9, 2022 accident involved an unscheduled vehicle.

b. Coverage is limited to situations in which scheduled autos are being operated for Mendieta and Sons Enterprises' commercial business use.

c. Failure to cooperate will result in no coverage being available under the express terms of the Policy.

d. Prime is entitled to reimbursement in the event it is obligated to make any payments pursuant to financial responsibility obligations under the MCS-90 Endorsement.

It is the intent of this Court that this Judgment disposes of all issues and all parties and that it is a final, appealable order.
