Pursuant to Rule 56 of the Utah Rules of Civil Procedure, the Court hereby enters judgment in favor of Plaintiff Firmco Financial, Inc., in the amount of \$19,187.10 against Defendants based on the following:

1. Damages in the amount of \$9,610.60 in principal, late fees, and interest as of April 23, 2026 based on a Declaration of Sharan Stults from Fimco Financial, Inc. already on file with the Court;

2. Post judgment interest at a rate of 5.51% per annum until paid in full;

3. Reasonable attorney fees in the amount of \$9,067.50 pursuant to a Declaration of Attorney's Fees and Costs filed by counsel for Plaintiff already on file with the Court; The court excludes the following from the fees request because the court finds the work was not necessary or reasonable: 7/17/2024 1.00 \$325.00 \$325.00 Prepare Request for Entry of Default against Jake Spencer. Prepare Declaration in Support of Request for Entry of Default. Prepare Exhibit to Declaration. Prepare Declaration Regarding Military Service and Exhibit. Prepare Default Certificate. 9/23/2024 0.10 \$325.00 \$32.50 Receipt and review of notice from court about lack of signing default judgment against defendant Jake Spencer 4/13/2026 0.20 \$325.00 \$65.00 Receipt and review of mail returned sent to debtor including motion for summary judgment documents.

4. Court costs in the amount of \$509.00 pursuant to a Declaration of Attorney's Fees and Costs filed by counsel for Plaintiff already on file with the Court;

5. For a total judgment, including damages, attorney's fees and Court costs of \$19,187.10; and

6. Pursuant to the terms of the contract, Defendants are jointly and severally responsible for the liability to Plaintiff.

And it is further ordered that this judgment may be augmented in the amount of post-judgment interest at a rate of 5.51% per annum, ~~or at the highest interest rate allowable by~~

~~law~~, until paid in full, and reasonable attorney fees and costs incurred in collecting and enforcing the judgment, if approved by the court, such augmentation to take place in accordance with Rule 73, Utah Rules of Civil Procedure.
