The court decrees:

Divorce

1. AGUSTIN A MORA GALEA is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by AGUSTIN A MORA GALEA. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **AGUSTIN A MORA GALEA** and **LORENA TORRES MONEY** do not have any children together.

Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
