Judgment is entered against all Defendants jointly and severally in the following amounts:

- a. \$9,986.45 for past medical expenses,
- b. \$18,802.21 for past lost wages ~~through the end of 2024,~~
- c. \$7,260.26 for prejudgment interest on past economic damages at the statutory rate of 8.75% per annum through April 23, 2026,
- d. \$35,000.00 for non-economic general damages.

Plaintiff is further awarded costs of suit in the amount of \$375.00 for the filing fee and \$55.00 for service of process. The total principal judgment against all Defendants jointly and severally is **\$71,478.92**.

This judgment shall accrue post-judgment interest beginning on April 23, 2026, at the statutory rate of 5.51% pursuant to Ut. Code. Ann. 15-1-4.
