The court decrees:

Divorce

1. Nicholas Rafael Valladares is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Nicholas Rafael Valladares. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Nicholas Rafael Valladares and Polika Souvenir Valladares** do not have any children together.

- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- We are not expecting a child.

9. Polika Souvenir Valladares changed her name when the parties married. Polika Souvenir Valladares's name will be Polika Souvenir Tuigamala after the divorce. Judge's signature may instead appear at the top of the first page of this document.
