This matter having come before the Court upon the Verified Petition for Divorce filed by Jeffrey Allen Reese, and the Divorce Stipulation having been signed by both parties, and the Court having entered its Findings of Fact and Conclusions of Law, and good cause appearing,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

- 1. Divorce.** The marriage between Jeffrey Allen Reese and Olga Reese is dissolved, and each party is restored to the status of a single person.
- 2. Children.** The parties have no minor children together. No children are expected. The parties do not have incapacitated adult children together who are eligible for child support.

3. Personal Property. All personal property not specifically addressed in this Decree shall be confirmed as the separate property of the party currently in possession of it.

4. Vehicles. The vehicles shall be divided as follows:

a. The 2023 Tesla Model Y (VIN: 7SAYGDEE1PF676840), current value \$25,000.00, is awarded to Jeffrey Allen Reese as his sole and separate property. Jeffrey Allen Reese shall be responsible for all costs, liens, and obligations associated with this vehicle.

b. The 2017 Thor (Ford) Four Winds 22E (VIN: 1FDXE4FS6GDC40345), current value \$33,000.00, is awarded to Jeffrey Allen Reese as his sole and separate property. Jeffrey Allen Reese shall be responsible for all costs, liens, and obligations associated with this vehicle.

c. The 2024 KIA Sportage EX (VIN: KNDPVCDG8R7126801), current value \$24,000.00, is awarded to Olga Reese as her sole and separate property. Olga Reese shall be responsible for all costs, liens, and obligations associated with this vehicle.

5. Bank and Credit Union Accounts. The bank accounts shall be divided as follows:

a. UMB Bank Checking Account #8561, balance \$101,971.04, is awarded to Jeffrey Allen Reese as his sole and separate property.

b. UMB Bank Checking Account #3017, balance \$22,499.29, is awarded to Olga Reese as her sole and separate property.

6. Stock, Bond, Securities, or Money Market Fund Accounts. The investment accounts shall be divided as follows:

a. Wealthfront (UMB Bank) Individual Automated Investing Account #8561, balance \$51,562.01, is awarded to Jeffrey Allen Reese as his sole and separate property.

b. Coinbase Cryptocurrency Account, balance \$843.37, is awarded to Olga Reese as her sole and separate property.

c. Coinbase Cryptocurrency Account, balance \$2,920.19, is awarded to Jeffrey Allen Reese as his sole and separate property.

7. Debts. The parties are not aware of any debts from the marriage. If any debts exist, each debt shall be the sole responsibility of the party who incurred the debt. Each party shall hold the other

harmless from any such debts.

8. Real Property. The real property shall be divided as follows:

a. The property located at 1660 Major St, #8, Salt Lake City, UT 84115 (Tax ID: 16-18-162-008; Legal Description: UNIT 8, PENNY CONDO PH 1), with a current value of \$429,569.00, is awarded to Olga Reese as her sole and separate property. Jeffrey Allen Reese shall execute any and all documents necessary to transfer his interest in this property to Olga Reese.

9. Alimony. Neither party is awarded alimony.

10. Retirement Accounts. The retirement accounts shall be divided as follows:

a. Fidelity Roth IRA #8298, value \$5,213.15, in the name of Jeffrey Allen Reese, is awarded to Jeffrey Allen Reese as his sole and separate property.

b. Fidelity Rollover IRA #8295, value \$91,554.77, in the name of Jeffrey Allen Reese, is awarded to Jeffrey Allen Reese as his sole and separate property.

c. Wealthfront Roth IRA #Y9JY, value \$15,117.97, in the name of Olga Reese, is awarded to Olga Reese as her sole and separate property.

The owner of each retirement account (Plan Participant) must do whatever is necessary for both parties to have full access to information about the pension plan, retirement account, money, and benefits. This includes signing any forms needed for release of the information to the other party (Alternate Payee). If the Plan Participant receives any retirement money awarded to the Alternate Payee, the Plan Participant receives that money in a constructive trust for the Alternate Payee. The Plan Participant is ordered to pay the benefit directly to the Alternate Payee within 5 days of its receipt.

11. Duty to Sign Documents. Each party shall sign all documents necessary to comply with this Decree within 60 days from its entry. If a party fails to sign a document within 60 days, the other party may petition the Court to appoint someone to sign the document pursuant to Utah Rule of Civil Procedure 70.

12. Further Relief. Each party is granted such other and further relief as the Court deems equitable and just.
