The court decrees:

Divorce

1. Lindsey Julianne Murphy is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Lindsey Julianne Murphy. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Lindsey Julianne Murphy** and **Nora Kelmendi** do not have any children together.
- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
 - We are not expecting a child.
 - We do not have incapacitated adult children together who are eligible for child support, or, **Lindsey Julianne Murphy** is not asking for child support for any adult child who is eligible for child support.

Personal property (Utah Code Title 81, Chapters 1, 4, 6, and 9)

3. All personal property not addressed in the divorce should be divided as the parties have already divided it.

Debts

8. In the Plan Participant receives any retirement money awarded to the Alternate Payee, the Plan Participant receives that money in a constructive trust for the Alternate Payee.
