This matter comes before the above-referenced court by way of Petitioner Stephanie Soto's Verified Petition for Divorce. This Court having reviewed the parties' Settlement Agreement; does hereby find good cause to make and enter this Decree of Divorce, as follows:

1. Three Month Residency. Petitioner Stephanie Soto ("Stephanie") was a resident of Salt Lake County, Utah on the date this case was filed. Petitioner was a resident for at least three months immediately before filing this case.
2. Venue. That venue is proper in Utah County pursuant to Utah Code Ann. § 78B-3a-201.
3. Marriage. Stephanie and Respondent Michael J. Soto ("Michael") were married on December 14, 2013, in Taylorsville, Salt Lake County, Utah. The parties are currently married.
4. Separation. The parties separated on or about May 1, 2024.

5. Grounds. The parties are granted a decree of divorce pursuant to Utah Code Ann. § 81-4-405(1)(h) as irreconcilable differences have arisen between them making their marriage irretrievably broken and impossible to continue.
6. Children. The parties have no minor children; nor are any children expected to be born as issue of the marriage.
7. Real Property. Each party is awarded the real property in their name, if any, free and clear of any claim from the other party.
8. Personal Property. Each party is awarded the personal property in their possession, unless otherwise specified herein.
9. Bank & Credit Union Accounts.
 - a. Joint Accounts. Neither party is aware of any joint bank and/or credit union accounts.
 - b. Separate Accounts. Each party is awarded, as his or her sole and separate property, all bank, credit union, and/or deposit accounts held in that party's individual name. Neither party will have any right, title, claim, or interest in the bank, credit union, and/or deposit accounts awarded to the other.
10. Life Insurance Policies. Each party shall retain ownership of any life insurance policies held in their own name.
11. Retirement Accounts. Each party is awarded, as his or her sole and separate property, all right, title, and interest in and to any investment and/or retirement accounts held in his or her individual name, including but not limited to any 401(k), IRA, pension, brokerage, or similar accounts.

12. Debts. There are no known joint marital debts. Each party shall be responsible for the debt in his/her own name.
13. Alimony. Neither party is awarded alimony past, present or future.
14. Maiden Name. If desired, Stephanie shall be restored the use of her maiden name - Stephanie Ontiveros Salas.
15. Duty to Sign Documents. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70).
