The above-captioned matter came on regularly for consideration by the court without hearing. Pursuant to the Stipulation and Property Settlement Agreement a judgment for a divorce can be entered. The court, having reviewed the pleadings on file herein, and having entered its *Findings of Fact and Conclusions of Law*, does now ORDER, ADJUDGE, and DECREE as follows:

1. Robert Scott is awarded a Decree of Divorce from Yingkun Li on the grounds of irreconcilable differences, the same to become final upon entry by the court clerk.

Provisions Relating to Debts and Obligations

- During the course of the marriage, the parties did not acquire any joint debts or obligations.
- Each party shall assume and pay their own individual debts and hold harmless the other

party from liability on all debts and obligations (i.e., *credit cards, utility bills*) incurred by that party after separation.

3. Pursuant to Utah Code 81-4-406(1) the parties shall notify respective creditors or obliges, regarding the division of debts, obligations, or liabilities herein and the parties' separate and current addresses.

Provisions Relating to Personal Property

4. **Personal Property:** During the course of the marriage, the parties acquired certain items of personal property. Each party shall be awarded the items in his or her control or possession as separate property, with the following exception:

5. **Vehicles:** Robert retains ownership of all vehicles.

6. **Accounts:** The parties shall be awarded the accounts in their own name as their separate property, free and clear of any claim by the other party.

Provisions Relating to Retirement Accounts

7. **Retirement Accounts:** During the course of the marriage, the parties have acquired pensions, retirement benefits, 401(k)s, IRAs, and/or deferred compensation plans. The retirement assets accrued during the marriage shall be awarded to the individual whose name the retirement account is associated with, free and clear of any claim by the other party.

Provisions Relating to Real Property

8. **Real Property:** Prior to the marriage, Robert acquired an interest in real property,

commonly known as 3383 W. 6880 S. West Jordan, Utah 84084. Robert shall be awarded the

home as his separate property, free and clear of any claim by Yingkun.

9. Alimony: Both parties to this action are able-bodied and employed, and neither party shall be awarded any alimony from the other.

10. Attorney's Fees: Each party shall bear their own costs and attorney fees.

11. Mutual Restraining Order: The parties shall be permanently restrained from bothering, harassing, annoying, threatening, and/or harming the other party at any time or in any place.

12. Robert shall provide Yingkun with an airline ticket to China and \$1,000.00 for travel expenses.
