Based on the Application for Judgment filed by Plaintiff Security National Life Insurance Company with the above-entitled Court, together with the Confession of Judgment on file in this matter and the Affidavit of Non-Payment submitted in support of the Application, judgment is hereby entered against Defendant Eduardo Barajas in the following amounts:

- 1) the current principal amount established in the Affidavit of Non-Payment of \$52,368.46; accrued interest at the rate of 18% per annum on the principal balances as of the following dates:
  - a. \$38,750.46 from 09/24/2025 through 09/29/2025 (per diem of \$19.11) in the amount of \$95.55;

- b. \$33,349.49 from 09/29/2025 through 09/30/2025 (per diem of \$16.45) in the amount of \$16.45;
- c. \$33,394.34 from 09/30/2025 through 10/03/2025 (per diem of \$16.47) in the amount of \$49.41;
- d. \$33,044.34 from 10/03/2025 through 10/07/2025 (per diem of \$16.30) in the amount of \$65.18;
- e. \$35,812.83 from 10/07/2025 through 10/13/2025 (per diem of \$17.66) in the amount of \$105.97;
- f. \$35,487.95 from 10/13/2025 through 10/16/2025 (per diem of \$17.50) in the amount of \$52.50;
- g. \$38,427.95 from 10/16/2025 through 10/17/2025 (per diem of \$18.95) in the amount of \$18.95;
- h. \$41,727.85 from 10/17/2025 through 10/20/2025 (per diem of \$20.58) in the amount of \$61.73;
- i. \$41,427.85 from 10/20/2025 through 10/27/2025 (per diem of \$20.43) in the amount of \$143.01;
- j. \$44,060.16 from 10/27/2025 through 10/28/2025 (per diem of \$21.73) in the amount of \$21.73;
- k. \$43,821.58 from 10/28/2025 through 10/31/2025 (per diem of \$21.61) in the amount of \$64.83;

- l. \$43,521.58 from 10/31/2025 through 11/05/2025 (per diem of \$21.46) in the amount of \$107.31;
  - m. \$46,109.08 from 11/05/2025 through 11/24/2025 (per diem of \$22.74) in the amount of \$432.04;
  - n. \$49,293.75 from 11/24/2025 through 12/12/2025 (per diem of \$24.31) in the amount of \$437.57;
  - o. \$52,062.41 from 12/12/2025 through 01/16/2026 (per diem of \$25.67) in the amount of \$898.61;
  - p. \$52,093.46 from 01/16/2026 through 05/01/2026 (per diem of \$25.69) in the amount of \$2697.44;
  - q. \$52,368.46 from 05/01/2026 through 05/12/2026 (per diem of \$25.83) in the amount of \$284.08;
- for the total accumulated interest of \$5,552.36;
- 2) attorney fees as provided in Paragraph 6 of the Confession of Judgment in an amount of \$350.00 pursuant to the provisions of Utah R. Civ. P. 73(f)(1); and
  - 3) court costs as provided in Paragraph 6 of the Confession of Judgment in the amount of \$35.00 (filing fee of \$35.00),
- for a total judgment of \$58,305.82.

It is further ordered that the above judgment shall be augmented in the amount of interest at the post-judgment legal rate of 5.51% per annum continuing from the date of this judgment

until paid, and also augmented with reasonable costs and attorney fees expended in collecting said judgment by execution or otherwise pursuant to the provisions of the contract attached to the Complaint filed in this matter subject to the court's approval.
