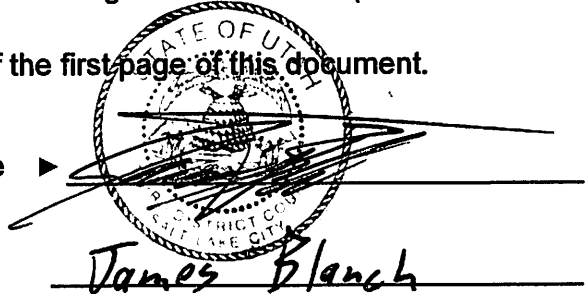
Duty to sign documents
