On April 27, 2026, a Webex hearing was held before Commissioner Blomquist on Aaron Poulsen's Second Motion to Enforce Order and for Sanctions and Judgment, and Jordan Poulsen's Emergency Motion to Stay and Emergency Motion to Vacate. Mark R. LaRocco appeared on behalf of Aaron Poulsen, who was present. Jordan Poulsen appeared pro se. Rebecca Ross appeared as Private Guardian Ad Litem ("PGAL") for K.P., who was not present. The Court entered an Order After Hearing on April 27, 2026, after having previously entered an Order After Hearing on July 18, 2023. Based on those hearings, Judgment enters as follows:

JUDGMENT

1. Pursuant to the Order After Hearing on July 18, 2023, Judgment was entered in the amount of **\$4,460**.

2. As of the hearing of April 27, 2026, because the prior Judgment is unpaid, post-judgment interest as allowed by U.C.A. 15-1-4 has accrued at 5.51 percent, in the amount of **\$578.34**.

3. Therefore, the prior Judgment has accumulated to **\$5,034.34**.

4. Pursuant to the Order After Hearing on April 27, 2026, Judgment enters for unpaid child support from July 2023 through March 2026 at \$153 per month in the total amount of **\$5,049**.

5. Therefore, the total Judgment due and owing is **\$10,083.34**.

6. The Judgment shall bear post-judgment interest at the legal rate from the date hereof until paid.
