Divorce

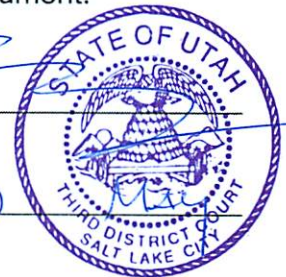
