Pursuant to Utah Code Ann. § 78B-5-205 and Rule 58A of the Utah Rules of Civil Procedure, and based upon (1) the Verified Statement in Support of Judgment by Confession of Form Med Spa, LLC, Form Med Spa II, LLC and Preston Daniel Ward and (2) the Verified Statement of Janie Ward in Support of Judgment by Confession, being fully advised in the premises, and good cause appearing, it is hereby:

ORDERED, ADJUDGED, AND DECREED that Judgment is hereby granted in favor of Plaintiff, Riverton CenterCal, LLC (“CenterCal”) and against Form Med Spa, LLC, Form Med

Spa II, LLC, Preston Daniel Ward, and Janie Ward (collectively, “Defendants”), jointly and severally, in the amount of \$450,000.00, less payments made and actually received by CenterCal pursuant to the Settlement Agreement between CenterCal and Defendants (the “Agreement”). This Judgment shall bear interest beginning on the date it is entered at 12% per annum and may be augmented to include attorneys’ fees.
