**ORDER AND JUDGMENT FROM
INFORMAL TRIAL
(MAY 1, 2026)**

On May 1, 2026, the Court held a bench trial on marital debts and assets before Judge L. Douglas Hogan. All Parties received proper notice according to the Utah Rules of Civil Procedure. Petitioner was present and was represented by his attorney, Jessica Read. Respondent was present and was represented by her attorney, Leilani Whitmer. The Guardian ad Litem was excused from attendance.

Parties reached a partial stipulation on the issues before the Court. Having received Parties knowing and voluntary partial stipulation, having heard Parties' remaining arguments on the issues, having reviewed the file, and good cause appearing, it is now Ordered:

1. Parties have agreed that Daniel shall give Alisha the mattress as compensation for the Parties' furniture loan.

2. Alisha shall be awarded a judgment of \$8,654 to be paid by Daniel. This amount is established to cover one-half of the USAA Credit Card Debt totaling \$4,500, the previously awarded attorney's fees totaling \$4,029, and \$125 for childcare expenses.

3. This resolves all issues before the Court on the Parties' original Decree of Divorce. The only remaining pending matters are the Parties' competing Petitions to Modify.
