Divorce

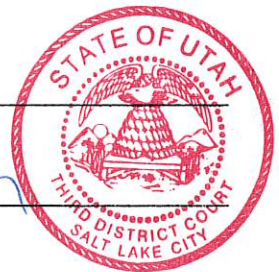
