This matter came on regularly before the Honorable Commissioner Kim Luhn on February 24, 2026, for a hearing on Petitioner's *Motion to Enforce* and Petitioner's *Motion for Temporary Orders*. The Petitioner was present and was represented by Kelli J. Larson. The Respondent was also present and appeared pro se. Based upon the pleadings on file herein, argument presented by the parties, and for good cause appearing:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED

Parent-Time:

1. Pursuant to Rule 106, the court ratifies that parent-time schedule the parties have been following for years. Father is awarded two hours per week of supervised parent-time.
2. Anna may continue to act as a supervisor or another agreed upon third party.

Miscellaneous:

3. Judgment is entered against father for unpaid child support of \$16,347.04 for the period of May 1, 2022 through January 31, 2026 .

4. The parties should attend mediation within 60 days.

5. The court admonishes Jared to pay his support but does not make a finding of contempt at this time.

6. A Review Hearing is set for May 6, 2026 at 10:00am with Commissioner Kim Luhn in-person at the Third District Courthouse located at 450 South State Street, Salt lake City, UT 84114.
