7. It is in the children's best interest that **Kayla Elizabeth Christiansen** be awarded Sole Legal and Sole Physical custody **Jared Robert Christiansen** should have parent-time at reasonable times and places.

8. The parents will follow a custom parent-time schedule:

a. **Jared Robert Christiansen can take L.C. for up to 5 hours for at least 2 of the weekdays, if not more. The times of pick up and drop off can be flexible depending on both Jared Robert Christiansen and Kayla Elizabeth Christiansen's schedules. The days that Jared Robert Christiansen is taking L.C. and the times must be decided by Sunday night the week of the visits. Jared Robert Christiansen can take L.C. to school**

any school day as long as Jared Robert Christiansen gives Kayla Elizabeth Christiansen at least a 24 hour notice. Kayla Elizabeth Christiansen will be picking L.C. up from school. Jared Robert Christiansen can have L.C. for 1 overnight every other week on Saturday nights. Parent-time transfers

10. Pick-up and drop-off ("transfers") of the children for parent-time will be as described below:

The parties will make arrangements for pick up, delivery and return of the children prior to each scheduled parent-time.

Curbside transfers

11. There will not be curbside transfers. The parent/person dropping-off or picking-up a child may accompany the children to the other parent/person when parent-time transfers are made.

Decision-making

12. Each parent will make day-to-day decisions for the children during the time they are caring for the children. Either parent may make emergency decisions affecting the health or safety of the children. A parent who makes an emergency decision must share the decision with the other parent as soon as reasonably possible.

Education plan

13. The school the children will attend is based on **Kayla Elizabeth Christiansen's** home residence.

14. Kayla Elizabeth Christiansen and Jared Robert Christiansen has authority to check the children out of school. Kayla Elizabeth Christiansen and Jared Robert Christiansen has access to the children during school. If the parents cannot agree, education decisions will be made by Kayla Elizabeth Christiansen.

Communication with each other

15. Parents will communicate with each other by any method.

Communication with the children

16. The parents agree they will:

- provide age-appropriate help to the children to communicate with the other parent.
- give the children privacy during their communication with the other parent. The parents will not interfere with or monitor communication between the children and the other parent.

17. Parents and children may communicate with each other whenever the children choose.

- By any method

18. Other terms about communication with the children: **If LC does not want to talk or communicate he will not be forced to do so.**

Records and information sharing

19. Other terms regarding records and information sharing:

Jared Robert Christiansen may have access to view records. Kayla Elizabeth Christiansen will have access to records and be the one to consult with providers. In the case of any emergency or major medical decision Kayla Elizabeth Christiansen will contact Jared Robert Christiansen.

Travel by the children

20. During their parent-time, the parent may consent for the children to travel with a sports team, religious group, school group, relatives, friends, by themselves, or with others.

21. If the children will be travelling for more than **3** days, the parent arranging the travel will notify the other parent at least **14** days in advance. That parent will give the other parent the travel schedule, locations and phone numbers at least **7** days in advance. In case of emergency, the parent will provide as much notice as possible.

22. Other agreements about travel by the children: **If a parent is planning on leaving the state for a vacation then the parent arranging the vacation must get the permission of the other parent before going on the vacation. If the other parent does not grant permission, a valid concern or reasoning must be presented.**

Child care

23. A child care provider for our children must be:

24. Other terms about child care: **If Kayla Elizabeth Christiansen or Jared Robert Christiansen are not able to babysit LC the preferred people to babysit LC are Kayla Elizabeth Christiansen's**

mom Karla Newland, Jared Robert Christiansen's sister Jessica Findlay and her husband Dallon Findlay, or a mutual friend. If all of these options are unavailable then Kayla Elizabeth Christiansen's sister Holly Jacobs should be reached out to. Corrie Christiansen shall not provide unsupervised or independent child care to Lucas Robert Christiansen under any circumstances. Robert Christiansen shall not provide unsupervised or independent child care to LC under any circumstances. However, Robert Christiansen is permitted to visit LC while LC is in Jared Robert Christiansen's care during Jared Robert Christiansen's scheduled parenting time as long as Jared Robert Christiansen is awake and present during the visit.

Relocation of a parent (Utah Code 81-9-209)

25. If either parent moves more than 149 miles from the other, the moving parent must give the non-moving parent a written Notice of Relocation. The notice must be sent at least 60 days before the planned move.

a. The written Notice of Relocation must include:

- Information about the move;
- A proposed parent-time schedule; and
- A statement that the parents will not interfere with the other parent's parent-time.

b. If the moving parent does not give the non-moving parent a Notice of Relocation, the moving parent will be in contempt of the court's order.

26. If either parent lives more than 149 miles away from the other, or if the parents live in different countries, parent-time will be as the parties agree. If they are unable to agree, the following will be the minimum parent-time for the noncustodial parent:

Relocation Schedule (Utah Code 81-9-209)

a. in years ending in odd number, the minor children will spend the following holidays with the noncustodial parent:

- i. Thanksgiving holiday beginning Wednesday until Sunday; and
- ii. spring break, if applicable, beginning the last day of school before the holiday until the day before school resumes;

b. in years ending in an even number, the minor children will spend the following holidays with the noncustodial parent:

- i. the entire winter school break period; and
- ii. the fall school break beginning the last day of school before the holiday until the day before school resumes; and

c. extended parent-time equal to $\frac{1}{2}$ of the summer or off-track time for consecutive weeks. The children will be returned to the custodial home no later than seven days before school begins. This week will be counted when determining the amount of parent-time to be divided between the parents for the summer or off-track period. The parties will mutually agree on this extended time each year. If they are unable to agree, the noncustodial parent will select the dates for the extended time period.

d. One weekend per month at the option and expense of the noncustodial parent. The noncustodial parent's monthly weekend entitlement is subject to the following restrictions.

i. If the noncustodial parent has not designated a specific weekend for parent-time, the noncustodial parent will receive the last weekend of each month unless a holiday assigned to the custodial parent falls on that particular weekend. If a holiday assigned to the custodial parent falls on the last weekend of the month, the noncustodial parent will be entitled to the next to the last weekend of the month.

ii. If a noncustodial parent's extended parent-time or parent-time over a holiday extends into or through the first weekend of the next month, that weekend will be considered the noncustodial parent's monthly weekend entitlement for that month.

iii. If a child is out of school for teacher development days or snow days after the children begin the school year, or other days not included in the list of holidays in Subsection (5) and those days are contiguous with the noncustodial parent's monthly weekend parent-time, those days will be included in the weekend parent-time.

e. The custodial parent is entitled to all parent-time not specifically allocated to the noncustodial parent.

27. If either parent lives more than 149 miles away from the other or the parents live in separate countries, costs for the children's travel expenses for parent-time will be paid by **the the parent who moved, except one-half of the expenses for the summer or off-track time will be paid by the other parent.**

28. If a parent has been found in contempt for not being current on all support obligations, and they do not have primary physical care of the child, they will be responsible for the child's related travel expenses.

29. Reimbursement for the child's travel expenses must be made within 30 days of receipt of documents detailing those expenses.

Changing the plan

This plan remains in effect until changed. A change comes from a modification of a court order.

31. **Jared Robert Christiansen's** gross monthly income for child support purposes is **\$1232**. **Jared Robert Christiansen's** base child support amount using the **sole** custody calculation is **\$60**. **Jared Robert Christiansen** receives the following gross monthly income:

- a. **Jared Robert Christiansen** does not have any countable income from any source.
- b. **Jared Robert Christiansen** receives **\$2899** per month in public benefits from a housing subsidy program, the Job Training Partnership Act, Supplemental Security Income, Social Security Disability Insurance, Medicaid, SNAP, General Assistance, or other similar means-tested welfare benefits. This income does not count for child support purposes, (Utah Code 81-6-203(7)).
- c. **Jared Robert Christiansen** has the following income from any of these sources:

Source: Education income, Monthly amount: \$1,232.32

32. The adjusted gross monthly income for **Jared Robert Christiansen** is **\$1232**.

Child support (Utah Code Title 81, Chapter 6, Parts 1 and 2)

33. It is in the best interest of the children that **Jared Robert Christiansen** be ordered to pay child support to **Kayla Elizabeth Christiansen** as follows:

a. **\$60.00** per month base support. This amount complies with the Utah Child Support Act.

34. Once a child is no longer eligible to receive child support, the support amount for the eligible children should be recalculated using the child support worksheet (Utah Code Title 81, Chapter 6, Parts 1 and 2). The parties may not divide the base child support award by the number of children and subtract that amount from the prior child support amount.

35. The **sole** custody worksheet was used to calculate child support.

Kayla Elizabeth Christiansen's base child support amount is **\$645** per month.

Jared Robert Christiansen's base child support amount is **\$60** per month.

If physical custody of a child changes from what the court orders:

- The parent owing support must pay the support amount to whomever has physical custody of the child.
- The parent must pay the support amount without asking the court to modify the child support order.
- This does not apply to temporary parent-time changes. (Utah Code 81-6-104(4) and 81-6-205(8)(a)).

Child support reduction for extended parent-time

36. If a child lives with the non-custodial parent by court order or written agreement of

the parties for:

- 25 of any 30 consecutive days, base child support will be reduced by 50% for each child who lives with the non-custodial parent during that time. (Utah Code 81-6-211(1)(a)).
- 12 of any 30 consecutive days, base child support will be reduced by 25% for each child who lives with the non-custodial parent during that time. (Utah Code 81-6-211(1)(b)).

The custodial parent's normal parent-time and holiday parent-time do not count as an interruption of the consecutive day requirement.

37. If a child receives cash assistance through the T.A.N.F. or F.E.P. programs, any agreement by the parties to reduce child support during extended parent-time must be approved by the Office of Recovery Services.

38. Child support will be paid as follows:

The \$910 from the SSA for Lucas Robert Christiansen will be direct deposited to Kayla Elizabeth Christiansen from the SSA once representative payee is transferred to Kayla Elizabeth Christiansen.

39. The issue of past-due child support may be decided by future court or administrative action.

40. **Kayla Elizabeth Christiansen and Jared Robert Christiansen** will each pay half of any ORS fee.

- a. If a fee is withheld from payments to **Kayla Elizabeth Christiansen, Jared Robert Christiansen** will reimburse **Kayla Elizabeth Christiansen** for half the fee.

41. The parties must notify each other within 30 days of any change in their income.

42. The parties can ask to change this child support order by motion after three years from the date of its entry if:

- there is a difference of 10% or more between the amount previously ordered and the new amount of child support under the Utah child support guidelines,
- the difference is not temporary, and
- the amount previously ordered was not a deviation from the child support guidelines.

If the children receive TANF funds at the time an adjustment is sought, ORS will review the order and ask the court to adjust the amount if appropriate. (Utah Code 62A-11-306.2).

43. The parties can ask to change this child support order at any time by petition if there has been a substantial change in circumstances because of material changes in:

- custody;
- the relative wealth or assets of the parties;
- income of a parent of 30% or more;
- the employment potential and ability of a parent to earn;
- the medical needs of the child; or
- the legal responsibilities of either parent for the support of others.

(Utah Code 81-6-202 and 81-6-212)

The change must result in a difference of 15% or more between the amount previously ordered and the new amount of child support under the Utah child support guidelines.

The difference may not be temporary.

The court can consider natural or adoptive children born after the entry of the decree other than those in common to both parties as part of a request to modify an existing award subject to limitations in the law. (Utah Code 81-6-202(8))

44. The Office of Recovery Services (<https://ors.utah.gov/>) provides services to individuals who are seeking assistance in the collection or enforcement of child support orders.

Dependent children for tax purposes

45. **Kayla Elizabeth Christiansen** may claim the parties' children as dependents/exemptions for tax purposes.

Child health care (Utah Code 81-6-208)

46. The parties must provide health care coverage for the medical expenses of the dependent children. Health care coverage means coverage under which medical services are provided to a dependent child through: fee for service, a health maintenance organization, a preferred provider organization, any other type of private health insurance, or public health care coverage. Utah Code 81-6-101(14),

47. **Kayla Elizabeth Christiansen** must maintain medical, hospital, and dental care insurance for the dependent children if it is available at reasonable cost. If medical insurance is not available at reasonable cost then both parents must ensure the children have health care coverage. This may require applying for public health care coverage, such as CHIP or Medicaid.

a. If, at any time, a dependent child is covered by the medical, hospital, or dental insurance plans of both parents, the coverage will be as follows:

- **Kayla Elizabeth Christiansen's** insurance will be primary coverage.
- **Jared Robert Christiansen's** insurance will be secondary coverage.

b. If a parent remarries and that parent's dependent child is not covered by that parent's health, hospital, or dental insurance plan but is covered by a step-parent's plan, the coverage will be as follows:

- **Kayla Elizabeth Christiansen's** spouse's insurance will be primary coverage.
- **Jared Robert Christiansen's** spouse's insurance will be secondary coverage.

c. Both parties will equally share the out-of-pocket costs of the insurance premiums.

d. Both parties will equally share all uninsured and unreimbursed medical and dental expenses that are reasonable and necessary. This includes deductibles, co-insurance, and co-payments paid by a party for the dependent children.

e. The party who pays health care expenses must provide the other party written verification of the cost and payment within 30 days.

f. If a party does not follow this order and provide written verification, they may not be able to receive credit for health care expenses or recover the other party's share of the

expenses.

g. On or before January 2 of each year, the party ordered to maintain coverage must provide verification of coverage to the other party, and ORS, if they are involved.

h. If there is any change in coverage, within 30 days of the change the party ordered to maintain coverage must notify the other party and ORS, if they are involved.

Child care expenses (Utah Code 81-6-209)

48. Both parties will equally share all reasonable work, career, or occupational training-related child care expenses.

a. The party who pays child care expenses must provide the other party written verification of the cost and identity of the child care provider. This must be done when a provider is first hired, and any time the other party asks for the information. The party incurring or paying child care expenses must notify the other party of any change of a child care provider or monthly expense. This must be done within 30 calendar days of the change.

b. The party not directly paying for child care must pay their share of child care expenses as soon as they receive verification of the expenses.

c. If a party does **not** follow the order and provide written verification, they may not receive credit for work, career, or occupational training-related child care expenses or recover the other party's share of the expenses.

Divide as follows: **The entire account should be awarded to Kayla Elizabeth Christiansen.**

Additional provisions

62. The parties will adhere to the following additional provisions:

a.

Additional Provision: **When the lease is finished at the Herriman location Kayla will give Jared a minimum of \$150 for LC's child care costs while LC is with Jared. This amount can be discussed between Jared and Kayla as finances change.**

b.

Additional Provision: **Visitation Provisions: In the event of a pre-planned family/friend event, or unexpected/unplanned event that takes place during the opposite parent's time, Jared Robert Christiansen and Kayla Elizabeth Christiansen will come together to discuss a possible compromise in visitation at least 1 week in advance depending on each parent's plans. If Jared Robert Christiansen is unable to take LC for the allotted amount of time on any visitation day, Jared Robert Christiansen would need to make arrangements for LC to be returned to Kayla Elizabeth Christiansen, to Karla Newland, or to a mutual friend. These arrangements include, Jared Robert Christiansen driving LC, having Jessica Findlay or Tiffany Christiansen drive LC, or having LC picked up. Jared Robert Christiansen and Kayla Elizabeth Christiansen will revisit the discussion of visitation one year after the divorce is finalized. Meaning that Jared Robert Christiansen and Kayla Elizabeth Christiansen will evaluate Jared Robert Christiansen's ability with the mediation of a non involved third party or a medical review to take care of LC for periods of time long periods of time and Jared Robert Christiansen's ability to take care of LC without another adult in the same house as Jared Robert Christiansen. We can also revisit what visitation looks like during the school year since LC will be going into Kindergarten around that time. If Jared Robert Christiansen is unable to take LC during his visitation time for any reason, that time is forfeit. Jared Robert Christiansen and Kayla Elizabeth Christiansen will discuss additional days or times that LC can go with Jared Robert Christiansen as they come up. If Jared Robert Christiansen is unable to drive**

but still is able to take care of LC during one of Jared Robert Christiansen's visits, Jared Robert Christiansen may call Kayla Elizabeth Christiansen with at least a 6 hour notice to have Kayla Elizabeth Christiansen drop Lucas Robert Christiansen off to Jared Robert Christiansen.

Duty to sign documents

63. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
