The Court previously entered an Order granting Plaintiff Prime Insurance Company (“Prime”)’s Motion for Default Judgment on May 30, 2026. Accordingly, pursuant to Rule 58A of the Utah Rules of Civil Procedure, the Court hereby enters final declaratory judgment in favor of Prime against AD Express Trucking LLC (“AD Express”) as follows:

1. Jurisdiction and venue are proper in this Court and county.
2. Based on the evidence submitted, the facts of the case, and the arguments made in the pleadings, the Court has determined that a hearing is not necessary.
3. Under the undisputed facts of this case, it is hereby ordered:

(a) Prime is not obligated to continue defending AD Express for the Huskic claim once the Policy limit has fully eroded.

(b) Under Exclusion No. 24 of the Policy, there is no coverage for punitive damages, court costs, or attorney fees.

(c) Under Exclusion No. 3 of the Policy, there is no coverage for claims involving negligent hiring or supervision.

(d) Prime's obligations for the Huskic claim are limited by the federal financial responsibility laws set forth in the MCS-90 Endorsement.

(e) Under the terms of the Policy and the MCS-90 Endorsement, AD Express and Azamat Asadov are required to reimburse Prime for any payments Prime makes toward uncovered claims.

It is the intent of this Court that this Judgment disposes of all issues and all parties and that it is a final, appealable order.
