The above-entitled matter came on for a Review Hearing on April 16, 2026, before Commissioner RENEE BLOCHER. Petitioner, MERANDA ANNETTE KIMBALL, appeared via WebEx and represented herself pro se. KIEL KANE KIMBALL, appeared via WebEx and represented himself pro se. Following review of the file and proffer presented Commissioner Blocher recommends that the Court shall strike Kiel Kane Kimball's Answer based on the parties stipulated agreement to finalize the divorce. The Court therefore enters Kiel Kane Kimball's default and strikes his Answer. The Court, having found and entered its Findings of Fact and Conclusions of Law and being otherwise fully advised, it is hereby,

ORDERED, ADJUDGED AND DECREED

1. Meranda is hereby awarded a Decree of Divorce from Kiel, such to become final upon signature and entry herein.

Three-month Residency

2. Meranda Annette Kimball and Kiel Kane Kimball were residents of Salt Lake County, Utah on the date this case was filed. Meranda Annette Kimball and Kiel Kane Kimball were residents for at least three months immediately before filing this case.

Marriage

3. Meranda Annette Kimball and Kiel Kane Kimball were married on Apr 1, 2024 in Salt lake City, Salt Lake County, UT. We are currently married.

Grounds and Divorce

4. Meranda Annette Kimball asks for a divorce from Kiel Kane Kimball on the grounds of irreconcilable differences. The irreconcilable differences are:
One or both of us has done things that have damaged the marriage beyond repair, and despite best efforts, the marriage can no longer be sustained.

5. Meranda Annette Kimball and Kiel Kane Kimball separated on Sep 20, 2024.

Children (Utah Code 81-6-101(7))

6. Meranda Annette Kimball and Kiel Kane Kimball do not have any children together.

- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- We are not expecting a child.
- We do not have incapacitated adult children together who are eligible for child support, or, Meranda Annette Kimball is not asking for child support for any adult child who is eligible for child support.

Personal Property (Utah Code Title 81, Chapters 1, 4, 6, and 9)

7. All personal property not addressed in the divorce shall be divided as the parties have already divided it.

Debts

8. The parties are not aware of any debts from the marriage. If any debts exist, each debt will be the responsibility of the party who incurred the debt.

Real Property

9. The parties do not have any real property that is marital property. The parties do not need a court order about real property.

Alimony

10. Neither party will pay alimony.

Retirement Money

11. The parties do not need a court order about retirement money.

Duty to Sign Documents

12. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

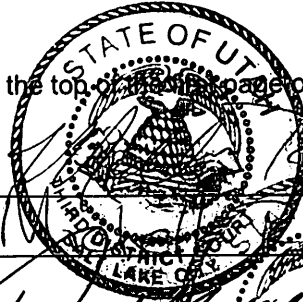
Name After Divorce
