**RENEWED AND AUGMENTED
DEFAULT JUDGMENT**

The motion of assignee Century Recovery LLC (hereinafter “Assignee” or “Century Recovery”) to renew and augment its judgment against Defendant Timothy James Staley, (hereinafter “Defendant”) came before the court for a decision. Having reviewed the documents filed in connection with the motion, and good cause appearing, IT IS HEREBY ORDERED THAT:

1. The facts set forth in the Declaration of Kevin M. Bischoff in Support of Motion to Renew and Augment Default Judgment against Defendant are accurate.
2. Notice of Assignee's Motion to Renew and Augment Default Judgment has been sent to the most current known address for Defendant.
3. Based on the evidence provided, and good cause appearing, Assignee's Motion to Renew and to Augment Default Judgment entered against Defendant on June 19, 2018, (the "Judgment"), is GRANTED.
4. The Judgment is renewed for an additional eight years from the date this order is entered or from the scheduled expiration date of the Judgment, whichever is earlier, as provided by Utah Code Ann. § 78B-6-1804.
5. The Judgment is hereby augmented, such that Assignee is now awarded a judgment against Defendant in the amount as follows:

6. Interest shall continue to accrue on the entire Judgment herein at the default rate of 3.76% per annum, as stated in the Judgment entered on June 19, 2018, from the date of the entry of the renewed and augmented judgment until paid in full.
7. This judgment may be further augmented in the amount of, interest, reasonable costs, and attorney fees incurred in collecting, preserving, and enforcing this judgment.
