Divorce

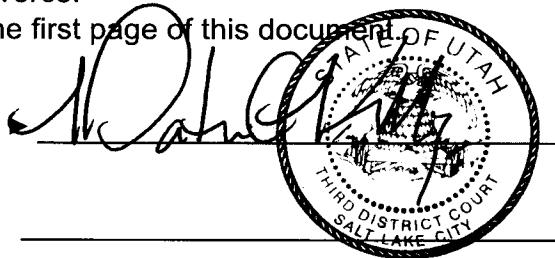
