- one half by the 5th day of each month, and
- the other half by the 20th day of each month.

21. Alimony not paid by the 5th day of the month is past due on the 6th day of the month. Alimony not paid by the 20th day of the month is past due on the 21st day of the month. If the Office of Recovery Services is used to collect child support then ORS may also collect alimony and their payment schedule will be followed.

22. **Joseph Michael Espinosa's** alimony obligation will end the earliest of the following:

- **29 years and 1 months**.
- If **Jamie Renee Myers-Espinosa** dies.

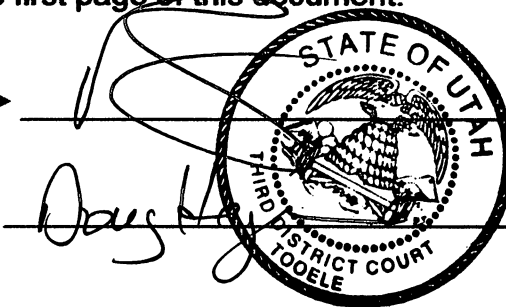
