Divorce

16. **Leonard Michael Vidaure** and **Shamra Lauraleeann Vidaure** have been married for **5 years and 0 months**.

17. There are special reasons (extenuating circumstances or good cause) for alimony to last longer than the length of the marriage: **Alimony should be paid from the time Leonard Michael Vidaure began to abandon the marriage and have affairs beginning May 26th 2020 when he was told by the petitioner if he did not want the marriage he should divorce and do it the right way but he refused to divorce the petitioner and instead all these years continued to have several affairs and brag about them and the money he is making acting though he is not married while petitioner remained celibate the entire time as a married woman should. Alimony should last for the 5 years 0 months after the filing of divorce sense the marriage lasted 5 years due to Leonard refusing to divorce, making that 10 years 0 months in total.**

Alimony Payment The parties married on March 18, 2020, and separated on May 26, 2020. Given the short duration of the parties relationship after the marriage, the Court determines that alimony is inappropriate. The Court therefore awards no alimony.

~~20. **Leonard Michael Vidaure** will pay **Shamra Lauraleeann Vidaure** **\$0,085.00** in alimony each month.~~

21. These are the reasons for this amount: **Leonard insisted we had to rush to get married faster than i wanted to because of the pandemic he rushed me into it then abandoned the marriage and went on to have multiple affairs refusing to divorce me when I insisted if he did not want the marriage he should do things the right way and divorce me so we both could move on, he claimed he wanted to find a way for us to be together but just completely abandoned the marriage continuing to have affairs with multiple women, ghosting me, leaving me with no way at all to reach him refusing to divorce me bragging on his YouTube channel about all the money he makes and women he sleeps with while I stayed celibate as a married women should and struggled as a single mom with my health going downhill after he swore to take care of me through sickness and in health.**

22. Alimony will start on **May 26, 2020** for the following reason: **The reason for the custom start date is when Leonard began to have affairs and abandon the marriage while still trying to convince me that he was trying to find a way for us to**

be together and be a family. These affairs with other women continued until he fully abandoned the marriage and refused to divorce me. To this day he brags on his YouTube channel about all the women he sleeps with and how he is making 35k monthly. While I have stayed celibate, and continue to struggle as a single mother with my health deteriorating.

23. The payment schedule will be:

- one half by the 5th day of each month, and
- the other half by the 20th day of each month.

24. Alimony not paid by the 5th day of the month is past due on the 6th day of the month. Alimony not paid by the 20th day of the month is past due on the 21st day of the month. If the Office of Recovery Services is used to collect child support then ORS may also collect alimony and their payment schedule will be followed.

~~25. **Leonard Michael Vidaure's alimony obligation will end the earliest of the following:**~~

- **Alimony should end when the person receiving alimony dies, remarries or cohabits with someone else, however past due alimony shall still be paid until paid off.**

27. The parties will adhere to the following additional provisions:

Additional Provision: If the court does not see the requested Alimony amount as a fair and just amount petitioner asks that the court award whatever amount the court feels is a fair and just amount.

Duty to sign documents

28. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

29. **Shamra Lauraleeann Vidaure** changed her name when the parties married. **Shamra Lauraleeann Vidaure's** name will be **Shamra Lauraleeann Coates** after the divorce.
