Additional Provision: **Any property that is not listed will be divided based on Alyssa and Sheldon's digression within 7 days of this decree being finalized.**

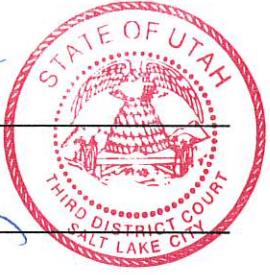
