This matter came before the Honorable Commissioner Russell Minas on June 8, 2026, on Tara Yuen's ("Tara") Motion to Enforce. Tara was present and represented by counsel, Jennifer L. Percy. Robert Yuen ("Robert") was properly served with the Order to Appear and failed to appear.

Based upon the pleadings on file, proffers and argument from counsel, and for good cause appearing hereby FINDS, ORDERS, ADJUDGES, AND DECREES as follows:

1. Robert owes Tara \$15,600.00 for alimony arrears from September 1, 2022, through April 1, 2025.

2. Robert owes Tara \$40,722.00 for the marital debts he was supposed to service and otherwise pay, per the Decree of Divorce. He failed to do so, and Tara had to pay off these debts.

3. Robert made two payments to Tara for \$2,250.00 in May 2026 resulting in a \$4,500.00 credit towards the forgoing judgment.

4. A judgement is hereby entered against Robert in the amount of \$51,822.00 in favor of Tara, with post judgment interest of 5.51%.

5. Tara shall be awarded her attorney fees associated with her Motion to Enforce and the June 8, 2026, hearing, to be determined by an Affidavit of Attorney Fees and proposed order. The issue of an award of attorney fees for any future motion(s) and/or hearing(s) is hereby reserved.
