Error: Reference source not found (hereinafter “Benjamin”) has submitted an Affidavit as to residency and grounds for divorce and Notice to Submit for Decision. The Court finds that Error: Reference source not found (hereinafter “Mallory”) has accepted service, appeared, consented to default and waived the 30 day waiting period, in writing. The Court entered Sherry's default. The Court, having made its findings of fact and conclusions of law, adjudges, decrees and orders as follows:

1. The bonds of matrimony and marriage contract between the parties are dissolved, and Error: Reference source not found is awarded a Decree of Divorce from Error: Reference source not found, to become final upon entry by the Court.
2. Each party is capable of supporting themselves. Therefore, no alimony should be awarded.
1. Debts
3. Benjamin is ordered to pay and assume the following debts: All debts in his name.

Benjamin shall hold Mallory harmless from any liability on these debts.

4. Mallory is ordered to pay and assume the following debts: All debts in her name.

Mallory shall hold Benjamin harmless from any liability on these debts.

5. Each party is ordered to pay and assume her and his own debts incurred after the parties' separation. Each party shall hold the other party harmless from any liability on these debts.

6. Each party is ordered to notify respective creditors regarding the court's division of debts and liabilities and regarding the parties' separate current addresses.

2. Personal Property

7. The parties shall divide the personal property equitably.

8. The parties acquired two pieces of real property during their marriage located at: 15262 S. Steep Mountain Dr., Draper, Utah; and 635 Carter Notch Road, Jackson, New Hampshire.

9. The New Hampshire home is titled in Benjamin's name only and he is the only one liable for the mortgage. Benjamin is awarded all right, title and possession of the home free from any claim by Mallory. The Utah home is titled in Mallory's name only and she is the only one liable for the mortgage. Mallory is awarded all right, title and possession of the Utah home free from any claim by Benjamin.

10. Mallory shall be restored to her former name of Mallory Rae Millington, if she so desires.

11. Each party is awarded their own pension or retirement benefits accrued during the marriage.

12. Each party is ordered to execute and deliver to the other party any documents necessary to implement the provisions of the Decree of Divorce entered by the Court.
