If the Office of Recovery Services is used to collect child support then ORS may also collect alimony and their payment schedule will be followed.

Duty to sign documents

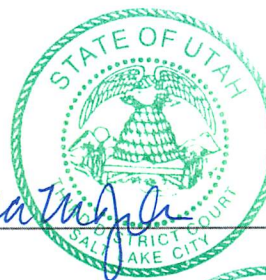

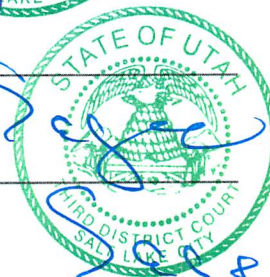
