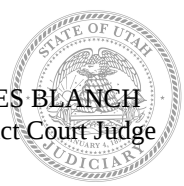

2. Respondent is hereby awarded \$3832.33 in attorney fees to be entered as a Judgment against the Petitioner, as outlined in Respondent's Motion for Attorney Fees, Affidavit of Attorney Fees, and invoices filed herewith, which shall be paid as a lump sum within 30 days of entry of this Order, and collected through the Office of Recovery Services.
3. The fees for services rendered, outlined in the supporting Affidavit, are reasonable for the work performed and are consistent with the rates charged in this locality for similar services.
