IT IS HEREBY ORDERED that Plaintiff Mulligan Funding, LLC be awarded judgment against Defendants LaWard Fitness, LLC d/b/a Gold's Gym/LaWard Fitness Inc. and Gilbert Ward, jointly and severally, as follows:

\$	150,476.67	Total Judgment

IT IS FURTHER ORDERED that interest shall continue to accrue at the rate of 27.75%, as provided for in § 30 of the Business Loan and Security Agreement, per annum from the date judgment is entered until the judgment is paid in full.

IT IS FURTHER ORDERED that this judgment may be augmented, subject to Court approval, in the amount of reasonable costs and attorney fees expended in collecting said judgment by execution or otherwise as shall be established by affidavit and ordered by the Court.

IT IS FURTHER ORDERED that this Judgment is a final judgment as contemplated by Utah Rule of Civil Procedure 54(b), and that there is no just reason for delay for entering the same.
