11. **Sarah Ross** changed her name when the parties married. **Sarah Ross's** name will

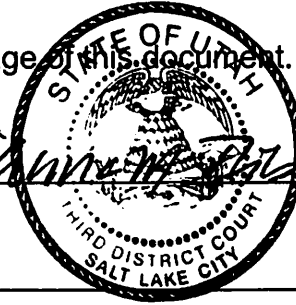
