This matter came before the Court on February 9, 2026, for a hearing on the Petitioner Nayitha Polgar's ("Petitioner") Motion to Enforce and for Sanctions, before the Honorable Commissioner Michelle Blomquist, who presided. Petitioner was present with counsel, Andrew J. Langeland, and Respondent was present with Counsel, Matthew Olsen. The Court, having reviewed the pleadings, evidence, and arguments of counsel, and being otherwise fully advised, awarded attorney's fees in favor of Petitioner and against Respondent Alan Polgar ("Respondent").

The Court finds that such fees were requested in conjunction with Petitioner's Motion to

Enforce. The amount of attorney's fees was subsequently established by Declaration, and Respondent did not object to the Declaration(s) within seven (7) days permitted.

Pursuant to the Court's ruling and Order, and the amount having been determined, the Court hereby enters Judgment as follows:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

1. Judgment is entered in favor of Petitioner and against Respondent as follows:
 - a. Attorneys Fees (Principal): \$10,816.75.
 - b. Pre-Judgment Interest: \$0.00
 - c. Costs: \$0.00
 - d. Total Judgment Amount: \$10,816.75.
2. This Judgment shall accrue post Judgment interest at the statutory rate of 6.73% pursuant to Utah Code § 15-1-4(3)(a).
3. This Judgment constitutes a final, enforceable judgment and may be enforced through all available legal remedies, including writs of execution and garnishment.
