This matter came before the court on March 04, 2026 regarding Plaintiff's Motion for Order to Show Cause. Plaintiff Meade Recovery Services, LLC was in attendance and represented by counsel, Jonathan E. Jenkins. Garnishee Defendant, Easy Moves Utah, LLC was served at served at 299 South Main, Ste 1300, Salt Lake City, UT 84111, but has failed to appear. The Court therefore finds:

1. Garnishee Defendant was properly served with a Writ of Garnishment on September 12, 2025.
2. Garnishee Defendant did not comply or respond to the Writ issued by the Court.
3. On January 07, 2026, Garnishee Defendant was served with an Order to Show Cause why Easy Moves Utah, LLC should not be held in contempt for failing to comply with said Writ.
4. Easy Moves Utah, LLC has failed to respond to the orders of this court or demonstrate that it has taken the required steps to secure the judgment owed by Defendant William Paipa.

Based upon the pleadings and information before the court, and good cause therefore appearing.

IT IS HEREBY ORDERED:

1. Garnishee Defendant, Easy Moves Utah, LLC failed to answer the Interrogatories to Garnishee relating to money due and owing to Meade Recovery Services, LLC, and failed to attend the Order to Show Cause hearing.
2. Plaintiff is awarded attorneys fee in the amount of \$350.00 for being required to bring this matter before the court.
3. The total judgment entered against Easy Moves Utah, LLC in favor of Meade Recovery Services, LLC for the value of defendant's property in the garnishee's custody or control, or the balance of the judgment, whichever is less. The current balance is \$1,893.27, which is the prior judgment amount of \$1,075.83 entered against William Paipa plus

these new costs: additional attorneys fee of \$350.00, accrued post judgment interest at the state approved rate, and additional costs incurred in collection of this judgment

Therefore, the amount of the judgment is calculated as follows:
