ORDER AND JUDGMENT

THIS MATTER came before the Court on Respondent Tori Rasmussen's *Motion for Entry of Judgments* filed April 3, 2026.

The Court, having reviewed the Motion, the records and files in this matter, including the *Decree of Parentage, Custody and Support* entered February 9, 2026, the *Affidavit of Attorney Fees* filed February 23, 2026, the *Affidavit of Beau J. Olsen for Attorney Fees* filed February 24,

2026, and noting that Petitioner Travis Stacey Peterson has failed to file any response or objection to the Motion and/or Affidavits within the time permitted by the Utah Rules of Civil Procedure, and good cause appearing,

HEREBY FINDS:

1. On February 9, 2026, the Court entered its *Decree of Parentage, Custody and Support*.
2. The *Decree* specifically awarded Respondent certain monetary amounts and directed that various obligations be reduced to judgment.
3. Respondent filed her *Motion for Entry of Judgments* on April 3, 2026.
4. Petitioner was properly served with the Motion.
5. Petitioner has not filed any response, objection, or other opposition to the Motion, and the time for doing so has expired.
6. The relief requested in the Motion is supported by the Decree and by the Affidavits filed with the Court.
7. Entry of judgment is appropriate to permit enforcement of the Court's prior orders.

IT IS HEREBY ORDERED:

1. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for child support arrearages through February 1, 2026 in the amount of \$3,773.73.
2. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for Guardian Ad Litem fees in the amount of \$4,252.50.

3. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for unpaid medical insurance premiums through January 1, 2026 in the amount of \$1,061.11.

4. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for unpaid medical expenses through January 1, 2026 in the amount of \$6,502.61.

5. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for unpaid childcare expenses through January 1, 2026 in the amount of \$6,943.89.

6. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for attorney fees awarded in connection with the August 19, 2024 proceedings in the amount of \$1,800.00.

7. Judgment is entered in favor of Tori Rasmussen and against Travis Stacey Peterson for attorney fees incurred after December 7, 2025 in the amount of \$13,020.00.

8. The total amount of judgments entered herein is \$37,353.84, together with statutory post-judgment interest as provided by Utah law from the date of entry of this Order.

9. Respondent may pursue all lawful collection and enforcement remedies available under Utah law, including collection through the Office of Recovery Services where applicable.
