Based upon Plaintiff's motion for default judgment and attorney fees (the "Motion"), and good cause showing therefor:

It is hereby ORDERED that Plaintiff's Motion is GRANTED. Judgment is awarded in favor of Plaintiff and against Defendant Waukegan Illinois Hospital Company, LLC in the amount of \$610,260.30 plus pre-judgment interest at the rate of one and one-half percent per

month, which is \$9,153.90 per month, from January 1, 2026 (which is the day after the most recent invoice was due) until judgment is entered, plus post-judgment interest at the rate of one and one-half percent per month, which is \$9,153.90 per month, until the judgment is paid, and attorney fees in the amount of \$2,346.00 and costs in the amount of \$639.82 as allowed per the Agreement. This judgment may be augmented to include the amount of Plaintiff's attorney fees, costs, and expenses incurred in the collection of this judgment, which shall be determined by declaration of Plaintiff's counsel.
