The court decrees:

Divorce

Duty to sign documents

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

9. **Kiyan Dawnel Sholes** changed her name when the parties married. **Kiyan Dawnel Sholes's** name will be **Kiyan Dawnel Coskey** after the divorce.
