Default Judgment is hereby entered in favor of Plaintiff and against Defendants in the following amounts:

1. The principal amount of \$79,416.11;
2. Costs and attorney fees in the amount of \$4,611.50; and
3. Post-judgment interest pursuant to UCA 15-1-4(3)(a), which is at the federal post judgment interest rate as of January 1 of this year, plus 2%. Post Judgment Interest is thus 5.51% from the date of entry of this Judgment.
