Divorce

Additional provisions

13. The parties will adhere to the following additional provisions:

a.

Additional Provision: Housing: Kate and Christopher agree that Christopher will move out of 2202 Hugo Ave by May 1st. Kate will remain at 2202 Hugo Ave, keeping Etta (dog). Kate will take responsibility for rent and other living expenses at 2202 Hugo Ave.

b.

Additional Provision: Banking/Lending/Accounts: MACU Joint: ***3342 AFCU Joint: *****6527** Kate and Christopher agree to remain as joint signers on Subaru Outback and Toyota Corolla vehicle loans. Kate and Christopher understand that in order to separate these loans, each would need to be paid in full via refinance, trade-in, or payment in full. Kate and Christopher understand the responsibility and risk each has as a joint signer on these loans. Kate has agreed to make on-time monthly minimum payments of \$197 to America First Credit Union on the Toyota Corolla balance (\$8,696.33). Christopher has agreed to make on-time monthly minimum payments of \$471.59 to Mountain America Credit Union on the Subaru Outback balance (\$25,928.59). Both the Subaru Outback and the Toyota Corolla are insured with Geico through August 2026. Kate and Christopher have agreed to keep insurance plan open and cancel this plan in August 2026. The monthly minimum payment of \$239.75 to Geico is automatically withdrawn from the Mountain America Credit Union joint account. Kate and Christopher have agreed to transfer \$119.88 each into the Mountain America Credit Union joint account before the 7th of each month for automatic withdrawals. Kate and Christopher also agree to remain as joint signers on both credit cards (Mountain America Visa & America First Visa). Kate and Christopher have both agreed to stop any charges to these cards after May 1st. Kate will assume responsibility of paying off the America First Visa balance (\$7,929) and Christopher will assume responsibility of paying off the Mountain America First Visa balance (\$8,371). Kate and Christopher understand that in order to separate these balances or remove each other from each balance, they would need to be paid in full via refinance or payment in full. Kate and Christopher understand the responsibility and risk each has as a joint signer on these credit card balances. Kate has agreed to make on-time monthly minimum payments on the America First Credit Union Visa balance, and Christopher has agreed to make on-time monthly minimum payments on the Mountain America Credit Union Visa balance. Kate and Christopher understand that because vehicle loans and credit card balances are joint, and payment in full is necessary to remove a joint signer, both Mountain America and America First accounts must remain open. Kate and Christopher have agreed to open separate accounts and suspend regular use of joint Checking & Savings accounts at Mountain America and America First. Christopher and Kate have changed their direct deposits and automatic withdrawals to their own accounts. Kate and Christopher still owe back-taxes to the IRS. The current IRS balance is: \$--. The monthly payment of \$180 is automatically withdrawn from the Mountain America joint account. Kate and Christopher have agreed to transfer \$90 each into the Mountain America Credit Union joint account before

the 10th of each month for automatic withdrawals. Kate and Christopher are renting a storage unit at StoragePlus in Midvale. Kate and Christopher have agreed to continue to share this storage unit for the time being. The monthly minimum payment of \$68 is automatically withdrawn from the Mountain America Credit Union joint account. Kate and Christopher have agreed to transfer \$34 each into the Mountain America Credit Union joint account before the 1st of each month for automatic withdrawals. Kate and Christopher have agreed to close the America First joint account as soon as the total Visa credit card and Toyota Corolla balances are paid off. Both understand that closing the account will also close the Visa credit line. Kate and Christopher have also agreed to close the Mountain America joint account as soon as the total Visa credit card, Subaru Outback, and IRS balances are paid off. Both understand that closing the account will also close the Visa credit line.

C.

Additional Provision: **Assets:** Kate and Christopher have agreed that Christopher will take the following items when he moves: - Roam AdventureCo rooftop tent - Fishing gear (rods, reels, waders, nets, etc.) - Camping gear - Record player, record player speaker, and records - PlayStation5 and PlayStation controllers Kate and Christopher have agreed that Kate will keep everything else at 2202 Hugo Ave that is not listed above (furniture, TVs, appliances, kitchenware, etc.)

Duty to sign documents

14. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

15. **Kate McCormick** changed her name when the parties married. **Kate McCormick's** name will be **Kate McMichael** after the divorce.

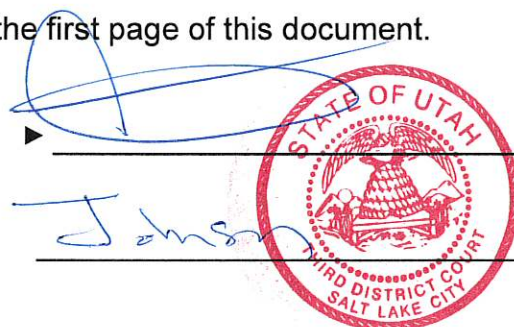
