This matter comes before the Court on Plaintiff's Motion for Summary Judgment, filed on June 2, 2026. The Court, having reviewed the Motion, and the Declaration of Gavn Meade filed in support thereof, and other information and evidence of record in this matter, and having previously entered Order Granting Summary Judgment, and for good cause appearing, now therefore

IT IS ORDERED, DECREED, AND ADJUDGED,

1. Plaintiff Meade Recovery Services, LLC., is awarded judgment against the Defendant Evelyn Laffarga, 5148 S 2325 W, Roy UT 84067, SSN: xxx-xx--1169, DOB: 12/13/1981 in the amount of \$8,204.97, as follows:

Said judgment shall incur interest at the rate of 24%, from the date of judgment until satisfaction or payment of the judgment in full, and may also be augmented in the amount of all reasonable costs and attorney fees expended in collecting said judgment or otherwise as shall be established by affidavit.
