IN THIS ACTION, Defendants Yoceline Salazar Zarate and Xtreme Auto Sales, LLC (the “Defendants”), having been served with process and having failed to appear and answer Plaintiff Granite Federal Credit Union’s Complaint on file herein, the legal time for answering having expired, and the default of the Defendants having been duly entered according to law, now upon application of Plaintiff to the Court, JUDGMENT IS HEREBY ENTERED as follows:

Judgment is hereby entered in favor of the Plaintiff and against the Defendant Yoceline Salazar Zarate (“Zarate”) for the amount due and owing to Plaintiff under the Note, as

such term is defined in the Complaint, which is \$7,433.80, plus interest at the contract rate of 9.24% from January 26, 2026, until paid in full;

Judgment is hereby entered in favor of the Plaintiff and against the Defendant Xtreme Auto Sales, LLC (“Xtreme”) for the remaining amount of the Check, as such term is defined in the Complaint, which is \$7,747.68, plus prejudgment interest at the statutory rate of 10% per year from October 6, 2025, until the date hereof, and post-judgment interest thereafter at the statutory rate until paid in full;

A Writ of Replevin and Writ of Assistance shall issue forthwith allowing Plaintiff to recover immediate possession of the 2022 Nissan Sentra, vehicle identification number 3N1AB8CV2NY291797 (the “Sentra”), wherever it may be located;

Judgment is hereby entered in favor of the Plaintiff and against Zarate in the amount due and owing to Plaintiff under the Negative Shares, as such term is defined in the Complaint, which is \$7,744.06, plus interest at the statutory rate of 10% from January 26, 2026, until paid in full;

Judgment is hereby entered in favor of the Plaintiff and against Zarate in the amount due and owing to Plaintiff under the Visa Card, as such term is defined in the Complaint, which is \$484.59, plus interest at the statutory rate of 17.5% from January 26, 2026, until paid in full;

Judgment is hereby entered in favor of the Plaintiff and against the Defendants, jointly and severally, for attorney’s fees of \$4,166.00 and costs of \$959.70;

The total judgment awarded to the Plaintiff against Zarate, excluding prejudgment and post-judgment interest is \$20,788.15;

The total judgment awarded to the Plaintiff against Xtreme, excluding prejudgment and post-judgment interest is \$12,873.38;

Once the Sentra has been recovered and sold, Plaintiff shall apply the net sales proceeds the amount under this judgment to reduce the amount by the Defendants; and

It is further ordered that this judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting the judgment by execution or otherwise, as allowed by statute or rule and approved by the Court.
