The court decrees:

Divorce

1. TristaLea Potts is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by TristaLea Potts. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **TristaLea Potts** and **Zachary Potts** do not have any children together.

7. The parties do not need a court order about retirement money.

Additional provisions

8. The parties will adhere to the following additional provisions:

Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

10. **TristaLea Potts** changed **her** name when the parties married. **TristaLea Potts's** name will be **TristaLea Marie Glore** after the divorce.
